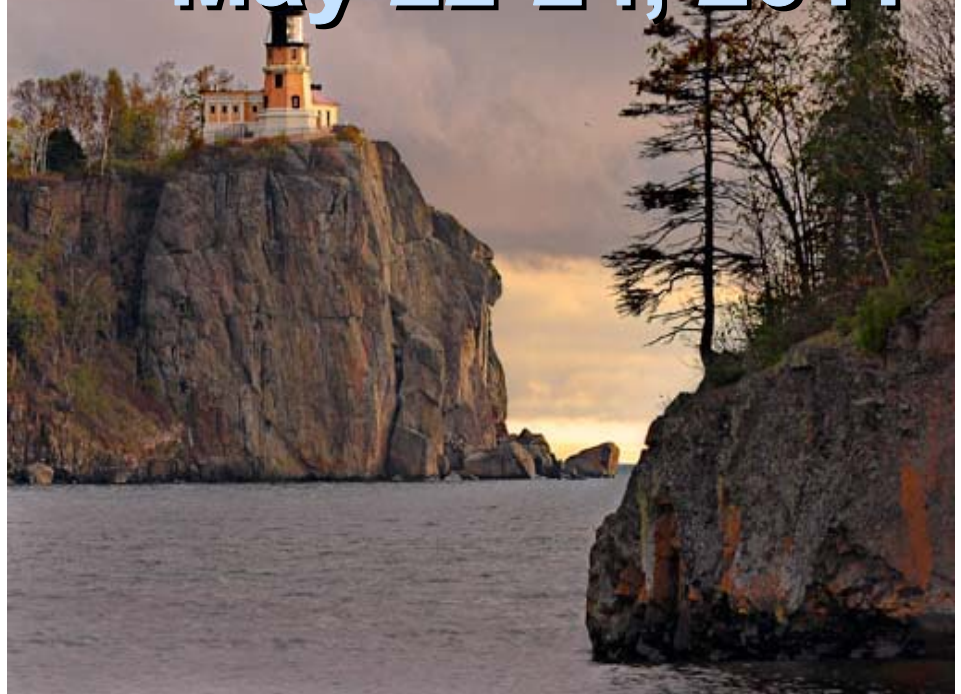

DAY 1 SUNDAY, MAY 22, 2011

Our deluxe motorcoach will take us "up north" with our first stop in the major **Great Lakes port of Duluth**. We'll have a **guided city tour** that will take us by the port of Duluth, the historic homes of the early lumber barons and shipping tycoons and along the **Skyline Drive**. You'll have the opportunity to climb to the top of **Enger Tower** or just meander up the path to the gazebo offering amazing views of Lake Superior and the City of Duluth below. You'll then have time to wander around **Canal Park** to have lunch on your own, do a little shopping or visit the **Marine Museum**. Or, you might want to just sit on a bench and watch the



freighters coming into port. Our next destination is our home for the next two nights, the new **AmericInn** located in **Silver Bay** along **Lake Superior**. Tonight relax in the pool or whirlpool, stroll along the shore, or play a little cards or a game in the hospitality room that has been reserved for our entire stay. DAY 2 MONDAY, MAY 23, 2011



It's north to **Ely** this morning through the beautiful **Finland State Forest** which is part of the **Superior National Forest**. Once in Ely, we'll start with the program "Wolf 101" at the **International Wolf Center**. After the program you'll have time to wander around the Center and grounds looking

at the exhibits and observing the current residents, Aidan, Maya, Grizzer and Denali. You'll have time in downtown Ely for lunch on your own and some shopping before we head over to the **North American Bear Center**.
